## DALY CITY'S UNSOLVED MYSTERY!

On August 16, 1942, the serenity of a Daly City Sunday was shattered by the wail of sirens, the roaring of police cars and fire engines, and the racing to the foot of San Bruno Mountain by hundreds of Daly City residents.

A U.S. Navy blimp was about to land on a Daly City street! Wandering in from the ocean, vagrant in the breezes, was the lighter-than-air ship L-8, a patrol blimp on a routine flight from its base of origin, Treasure Island.

It crashed with little damage on Bellevue Avenue, its door latched open. Everything in the gondola seemed in good order...with one great exception, **ITS CREW WAS MISSING!**

The mystery of the L-8 became Daly City's **UNSOLVED MYSTERY!** On Wednesday, May 16th, at 7:30 p.m., our next Guild meeting at Doelger Center, the background of the blimp and its crew, its flight, observation by other ships and planes, its chase inland by DC residents, will be chronicled by **Bunny and Ken Gillespie.**

Based on eye-witness accounts by many local residents, including Guild member **Frances Windhurst**, extensive research locally and nationally, the saga of L-8 will be told in narrated, illustrated manner, including several previously unpublished pictures.


Some of our eye-witnesses were discovered at Daly City gatherings. If any Guild members or friends are also eye-witnesses, please let us know so we can make such acknowledgment.

## PORTOLA PROGRAM A HIT



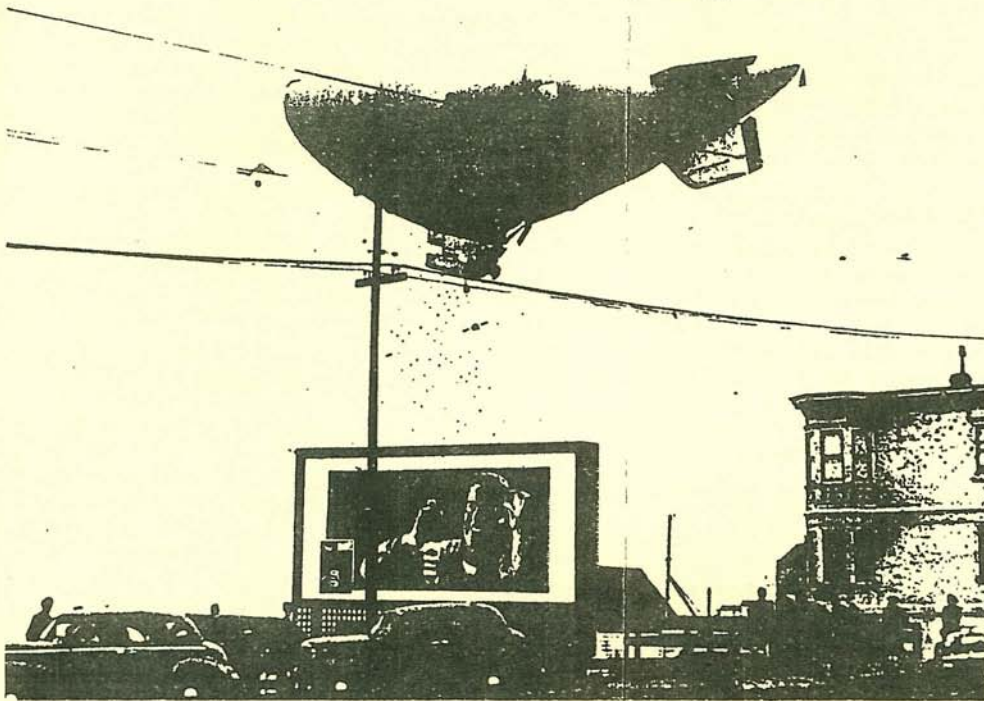

One of the markers at the Dueling Site had been broken off by vandals, but has since been repaired. The stationery was created by artist **Bob McClay** for the 75th Anniversary Celebration.

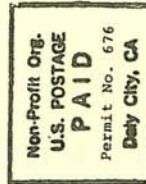

ready to be picked up at our next meeting:

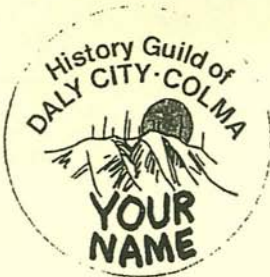
