GREETINGS FROM PRESIDENT MARK



That is when we will premiere our 50 minute feature-length Daly City Centennial documentary--'Daly City: Growing Up In America,' a co-production of the History Guild of Daly City-Colma and KM2 Communications of South San Francisco. This will take the place of the Guild's regular November meeting, and we hope that one and all can join us on this momentous occasion, which has been in the works for a very long time.

While the film begins at 7:00 PM [please see your formal invitation enclosed, which provides all the details], there will be a separate, brief reception beginning at 5:30 PM at City Hall hosted by the City. 

A PIMGRIMAGE TO ROBERT THORTON GRAVE SITE



My wife, Eunice, and I visited the cemetery containing the graves of Robert Sheldon Thornton and Sarah Ann Thornton at North Situate, Rhode Island, during late July 2012. North Situate is located just west of the state capitol, Providence, on U.S. Route 6. The cemetery is identified as the Smithville Cemetery on the United States Geological Survey Maps, but is known as the Rhode Island Historical Cemetery No. 24 (misidentified as No. 23 on the Internet.) Mr. Henry Duquette of the Rhode Island Historical Cemetery Commission met us there and led us to the graves.

Robert homesteaded 160 acres in the Sand Hills area of Colma, California, during 1852 as of Daly City's early pioneers.

The Thornton graves are located near the southeast corner of the cemetery. Robert's gravestone faces north and Sarah's faces east. Just to the left of Sarah's is a small gravestone for the "Son of Robert S. & Patia Townsend, died May 1, 1847, aged 3 months, 2 days." Patia was Robert's first wife. Just to the right of Sarah's is a missing gravestone which was once reaffixed, but is now lost. This may have been the gravestone of Robert and Sarah's first born as mentioned on Sarah's gravestone: "laid to rest in her North Situate burial plot with her first born."

The Thornton section was covered with macadam instead of grass, which Henry and I have never seen elsewhere in all the cemeteries that we each have visited. The long inscription on Robert's gravestone and no death date inscribed led Henry to believe that it was a memorial only rather than a gravestone. I told him that the information that I have stated that he was buried there, and I would forward some of my data that I have collected during the last six years. Henry noted that Robert was notable in Rhode Island for being a Captain in 1842, for the nearby town of Gloucester [Gloucester] by the Governor Samuel Ward King [1839-1843].



LOST BALLOTS? — 1911

Following our celebration of the Daly City Centennial, this fact is well known: On March 18th, 1911 a vote was held for the incorporation of Daly City. On March 22, Daly City was incorporated at the county offices with an official vote of 138-136.

Less well known is the controversy documented in our History Guild archives after the March 18th vote. An election protest was led by a local Socialist group (a number of early Daly City citizens and electeds were members of the Socialist party) and an official complaint against "Daly City, a pretended Municipal Corporation" was filed by J.F. Pankewicz who was a member of the 1911 Board of Elections. Mr. Pankewicz claimed he directly observed 46 ballots being set aside for various irregularities with the intent that they would be further examined and their legality determined. Pankewicz stated that there was a turmoil in the place where the canvass of votes was taking place and during the commotion J.L. Brown, one of the members of the Board of Elections, seized the ballots in question and would not allow examination by other members of the Board of Elections. On the advice of Justice of the Peace Ellis Johnson, the 46 ballots in question were sealed in an envelope and ordered delivered to the Board of Supervisors of San Mateo County for an official determination.

Another first-hand witness to the vote count, J.J. Kenigan, filed a deposition with the Superior Court vouching for the truth of Pankewicz's complaint. Pankewicz claims three votes for incorporation were in error, two should have been counted against and one should not have been counted because of invalidating erasures. His complaint further stated that the County Board of Supervisors failed to legally canvass and evaluate the 46 contested ballots. (Original complaint and deposition filed in the Superior Court, San Mateo County, History Guild archives).

Can we believe the account of these two eye witnesses, one an election official? What happened to the 46 contested ballots after they left the Daly City polling place, the upstairs backroom of Jack Letlos' Restaurant on Mission Road? Would official evaluation of the contested ballot have changed the vote for incorporation? These questions may only be answered by further historical investigation.

A better known voting controversy occurred at the Abbey House, a sometimes notorious early day saloon located at the Top-of-the-Hill across Mission Road from where John Daly would later establish his dairy. In 1856 it was owned by Chris E. Lilly, a member of a San Francisco gang that included Billy Mulligan. The gang decided to move their illegal activities south to a new county and "fix" the election to determine the establishment of San Mateo County. They pushed for a speedy election with the polling place at their headquarters, the Abbey Saloon. Abbey House was the polling place for the Colma precinct, which included most of the north end of the county. There were about 50 eligible voters in this precinct and 500 ballots cast. Gang members took over the polling places and brought ballot boxes with false bottoms. The election was later ruled illegal because of a technicality, the election was held too early, and a new election was set for May 1857.

MEMORIES OF KNOWLES GULCH, HIKING ON SAN BRUNO MOUNTAIN

Attributed to Mrs. Altieri, daughter of Mansueto Belli, transcribed from interview by Samuel Chandler, 1972.

"Mr. Knowles settled in Knowles Gulch, where Marchbank Park is now. We used to pick flowers and wild quince and currents. They lived in a paradise.

We used to pick poppies and iris on the hills of San Bruno Mountain. We hiked over the mountain to South San Francisco. We would hike to a large boulder and Father gave us a white towel to wave so he would know we were safe. Coming back over the mountain we would have to do the same thing. Nine or ten of us children were on these hikes.


